In formal response to the exit interview conducted with Russell County's Community Policy and Management Team (CPMT), Family Assessment and Planning Team (FAPT), and the Children's Services Act (CSA) coordinator on February 15, 2022 and pertaining to the recent Office of Children's Services (OCS) audit of the Russell County CSA program, the following comments are offered. First, we, the Russell County CPMT, would like to thank OCS and the auditors involved for their oversight, objectivity, and assistance throughout this audit process. We concur with the overall finding of no material non-compliance.

As to the discussion points and best practice suggestions communicated during this exit interview, Russell County CSA and CPMT offer remedies as follows;

- All concerns with the policies and/or procedures noted in the review of findings have been clarified through proposed revisions and are awaiting final review and approval by the Russell County CPMT.
- Efforts are currently being made to address the need for a Russell County CSA tab to be added to the Russell County website. Addition of this tab will provide a landing page for information on Russell County CSA services and funding process, as well as information on the CPMT's role.
- The strategic plan has been updated to a logic model which addresses "SMART" goal development. The newly revised strategic plan will be presented at the March 15, 2022 Russell County CPMT meeting for review and approval.
- The IFSP review process is being reviewed with plans to redesign the process by which any
 changes to the IFSP will be made. The CSA coordinator and Russell County FAPT will collaborate
 on revisions to the IFSP utilization review process to better reflect changes made to the original
 IFSP goals, objectives, and/or strategies.
- The reporting of services will be reviewed to ensure accurate recording categories are selected.

It is our intention to utilize this audit process and the recommendations made as a result from the findings to improve our policies, procedures, and processes by which we serve the local community. We

thank you for the opportunity to articulate a response to the suggestions made and hope to implement the stated remedies.
