




Top Three Gaps – Statewide Data

Changes from FY2017 to FY2019

- Community-based behavioral health services moved to the highest grouping (up 0.7%)
- Foster care services moved to the second highest grouping (up 0.9%)
- Family support services moved to the third highest grouping (down 5.4%)
- Educational (up 2.3%) and Other services (up 0.8%) remained in the same position
- Crisis services moved up one position (up 2.0%) and Residential services dropped to the lowest grouping (down 1.3%)

Children with intellectual and developmental disabilities replaced those with substance abuse as the third highest ranked population with service gaps in Community-based Behavioral Health Services. Youth with multiple mental health diagnoses and autism remained the top two groups.

Children with multiple mental health diagnoses (now #1) switched places with sex offending/sexual reactive behaviors (now #2) for the top two highest ranked populations with service gaps. Youth substance abuse replaced those involved with the juvenile justice for the third highest rated group with gaps in Foster Care Services.

Children with multiple mental health diagnoses remained the top ranked group with gaps in services. Youth with autism (now #2) and those with intellectual and developmental disabilities (now #3) replaced those involved with the juvenile justice, those with sex offending/sexually reactive behavior, and those with substance abuse in the top three groups with gaps in Family Support Services.
