Case Study A

Johnny, a 16-year-old, was referred to the court for excessive truancy by his public school and he has a history of behavior problems that resulted in multiple in-school suspensions. In April 2023, Judge Cartwright issued a CHINS (Child in Need of Supervision) order mandating consistent school attendance and improvement in academic performance. A referral was made to FAPT. FAPT recommended dialectical behavioral therapy for five hours per week from January through March 2025, at \$75 per hour.

Case Study C

On May 31, 13-year-old Monica arrived at school with bruises and reported to the counselor that her mother's boyfriend had pushed her during a domestic dispute with Monica's mother. The counselor notified Social Services, who, aware of ongoing domestic violence, obtained a protective order against Kenneth. Despite this, Monica returned to school three weeks later with new bruises from another altercation involving Kenneth. On July 1, 2024, she was placed in a TFC home.

The FAPT met on July 8, and recommended the following services:

- basic and enhanced maintenance (emergency rate)
- Private Foster Care Support, Supervision & Administration, and
- Mentoring.

Monica was determined IV-E eligible as of her placement date on August 15th. The CPMT approved all services for July and August 2024.
