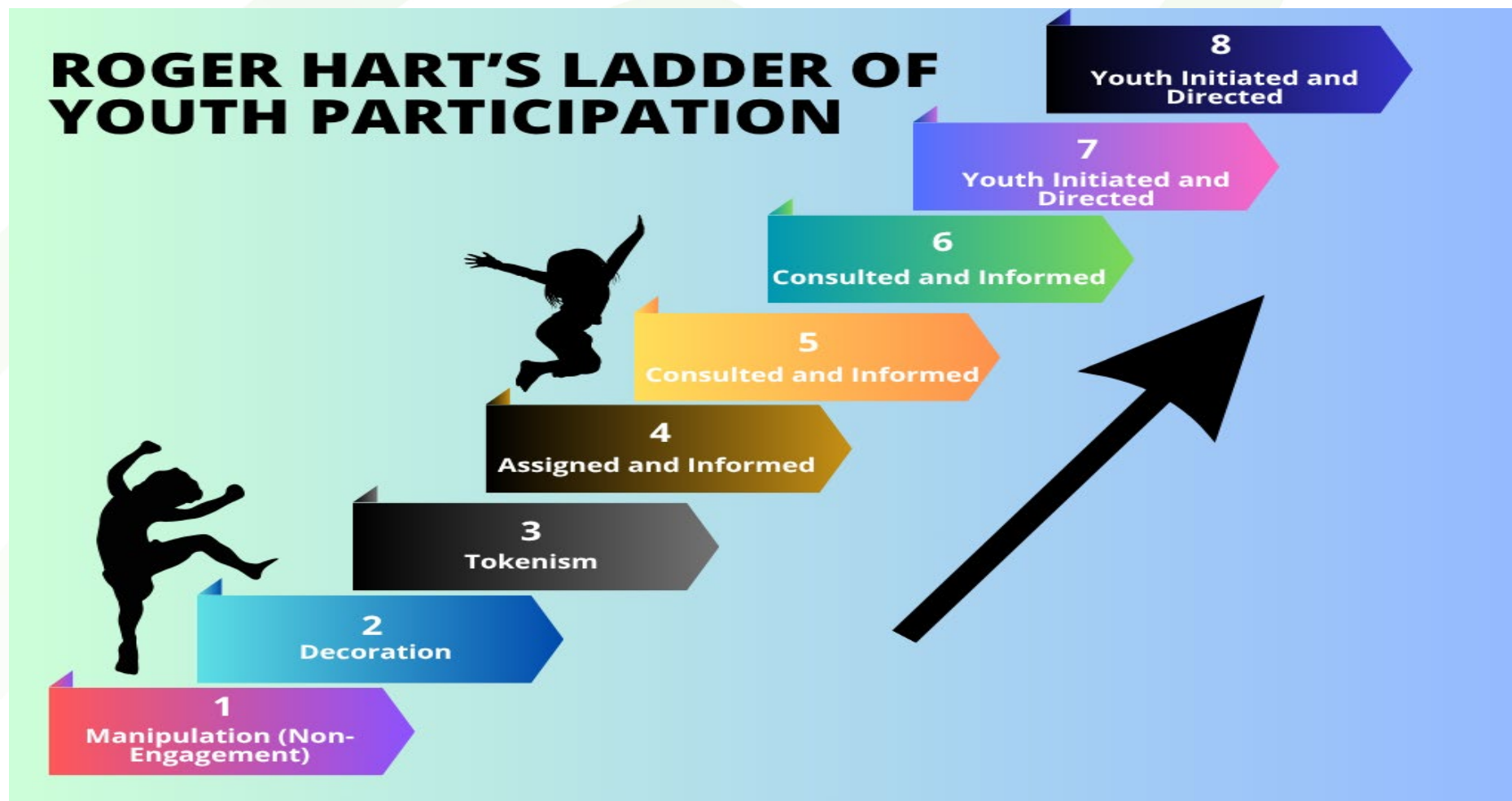
Authentic Youth Engagement (AYE)

AYE refers to the meaningful and intentional inclusion of young people in decision-making processes, where they have real influence and their perspectives are valued and acted upon—not just token involvement.

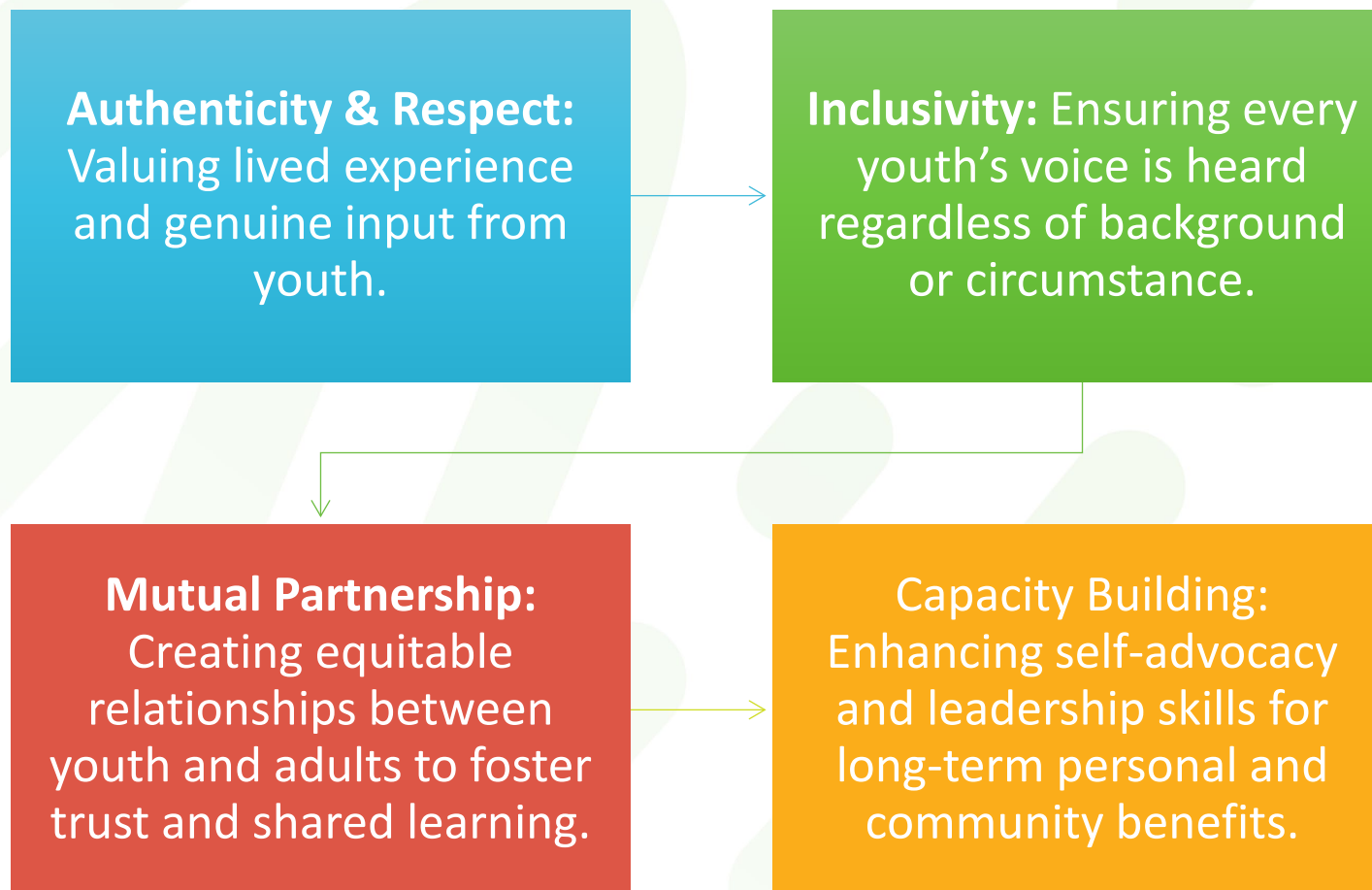
Authentic Youth Partnerships emphasizes creating opportunities for youth to collaborate as equal partners in shaping policies, programs, and practices that affect their lives.

Blind Spots to Youth Engagement

Adultism

- Not valuing lived experience and genuine input from foster youth.

Tokenism

- Youth are included just for appearance, not real input.

Lack of Access

- Limited opportunities for youth in decision-making spaces.

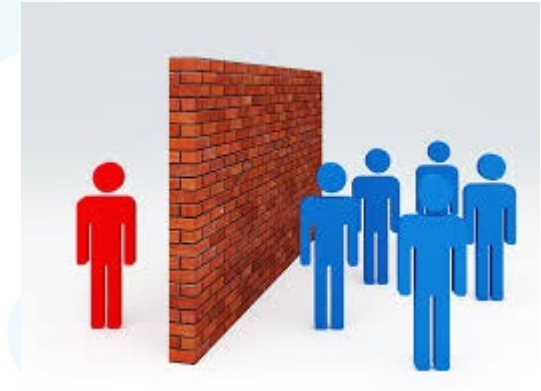
Stereotyping

- Youth being dismissed as “too young” or “inexperienced”.



Barriers to Youth Engagement

- Caseworker caseload and workload
- Casework turnover
- Frequent placement changes and mobility

Authentic Youth Engagement: Take a Trauma-Informed Approach

- Understand the impact of trauma on the child development and work to minimize its effects without causing additional trauma.
- Past trauma can cause youth to be initially resistant in building relationships, developing trust requires a significant time investment from the caseworker.
- Resistance is derived from trauma and caseworkers must help youth to work through potential barriers and provide consistent, responsive support for youth.

Elevating Youth Voice in Supervision

Tips to Support Caseworkers in Elevating Youth Voice

Model youth-centered practice during supervision

- Offer feedback on youth engagement based on observation of team meetings or home visits
- Incorporate youth voice in permanency goals
- Use role play during supervision-practice asking hard questions
- Create a culture of accountability – “Did the youth have a say in this decision?”
- Use reflection prompts for team meetings or huddles
- Review case file audits to see if documentation reflects youth voice



Intentional Strategies Of Youth Engagement

Strategies for Elevating Youth Voice

- Promote Normalcy
- Support youth's interest
- Celebrate small and large accomplishments
- Swap “worker visits” with “connection activities”
- Partner with other supportive adults
- Encourage youth to invite who they want present at meetings
- Provide varied options for engagement
- Connect Youth with peer supports systems
- Emphasize the importance of youth advocacy while youth are still in the system



Tools & Techniques for Fostering Youth Engagement

Digital Engagement Platforms:

Tools such as video conferencing, collaborative workspaces (e.g., Slack and Google Workspace), and social media channels enable consistent and flexible engagement among youth and adult partners.

Mentorship & Project-Based Learning:

Leadership boot camps, mentorship programs, and hands-on projects equip foster youth with essential advocacy, communication, and management skills.

Digital Storytelling:

Encourages youth to document and share their experiences, building community and amplifying their voices through accessible online formats.



Benefits of Youth Engagement



Benefits of Youth Engagement

Empowering Voices: Actively involving foster youth in decision-making (e.g., case planning and policy advocacy) builds self-esteem and a sense of agency.

Enhancing Outcomes: Real youth leadership drives improved behavioral, social, and developmental outcomes by fostering critical skills like communication, problem-solving, and advocacy

Policy & Program Benefits: Incorporating youth input leads to more effective, responsive policies and services that reflect the actual needs and experiences of foster youth.
